Your kind attention is solicited about the following:

1. **MEDICAL FACILITY** – The school provides **good medical facility** to all students. Any chronic medical problems requiring special/specific medical care or any problem of concerned should be brought to the notice of the school in writing by **25th July'2011** so that special care can be taken of that child. The school will not disclose the same. The school has its own Sickbay Clinic fully equipped with trained nurse all the time for the care of the students. The general medical check-up will be made for each student and same will be executed on regular basis.
2. **NO ELECTRONIC GADGETS ALLOWED** – You are requested to make sure that your child does not carry any Electrical Gadgets, Mobile Phone, I-Pod or any other unwanted material which is against the government policies and school's rules and regulations. In case the child is found with any such above items, the same will taken confiscated by the school and will not be returned back. You are humbly requested not to demand or argue for the same.
3. **NO VEHICLES** – It has been observed that few students are bringing vehicles outside the school premises. The students under 18 years of age are not allowed to drive any vehicle except cycle. If the student accompanies with this outside the school, the school will not be responsible for any consequences.
4. **PICK & DROP FACILITY** – The students who are not availing the school bus facility and opted for private vans/cabs should take care of their ward's pickup and drop. The school is not responsible for any unforeseen circumstances outside the school premises.
