This is with reference to your application dated 12.04.23 on the subject cited above. In this regard, the undersigned is directed to convey the approval of the Competent Authority for change of nomenclature of the school from existing **"GITARATTAN JINDAL PUBLIC SCHOOL, D-Blk., Sec.07, Rohini, Delhi-85"** to **"GITARATTAN GLOBAL SCHOOL, D-Blk., Sec.07, Rohini, Delhi-85"** from the academic session 2023-24 under Section 5(1 & 2) read with Rule 59 of DSEAR, 1973 subject to the following conditions :-

1. That the school shall get the Scheme of Management changed in New Name.
2. That the notification of the change in the name of the School will be published in atleast two leading Newspapers of Delhi within a week of date on which approval of Director of Education for change of name is received.
3. That the society will continue to abide by the conditions of Grant of Recognition/Up-gradation and various provisions of DSEAR, 1973 in all the matters connected with the affairs of the school.
4. That the school shall be managed by the same society i.e. "Rohini Educational Society" even after the receipt of approval of DoE regarding change of name from "GITARATTAN JINDAL PUBLIC SCHOOL" to "GITARATTAN GLOBAL SCHOOL".
5. That no branch of this school shall run under continuing name of Gitarattan Jindal Public School as recognized school in Delhi or around Delhi, by this Society.
6. That the change of name of the school shall be intimated to Registrar of Societies, GNCT of Delhi.
7. That the members of the Governing Body are not in Govt. Service.
8. That the society/management of the school shall be sole responsible for all litigations, if any, arising out of changed name.



11. That by changing the said name, there will be no change in the Managing Committee of the school.
12. That it is only change in name of the school from Gitarattan Jindan Public School to Gitarattan Global School and the character of the school will remain unchanged.
13. That Directorate of Education, GNCT of Delhi will not be responsible for any dispute arising out of the change of name of the school.
